Sub:- Anti-Ragging Committee Minutes of Meeting at Principal Office-Reg.

A Meeting by Anti-Ragging Committee along with HODs is conducted on 08-05-2024, 3:00 pm at Principal office, KIETW.

The following Agenda points were discussed during the Meeting.

- 1. The guidelines for the committee were set to action.
- 2. The use of visual aids was approved, where the number of the local SI and the local in-charge would be present in every poster that is made.
- 3. A promise to work for this cause was taken from all the members.
- 4. After a detailed discussion the committee members of the Anti-Ragging Committee was finalised.
- A brief discussion with parents, students and faculty gave us their respective concerns.
- 6. A special in-charge to resolve any matter which includes girls was appointed.
- 7. Different actions, which are to be taken in case of any complaints were discussed.
- 8. It was made sure that the committee had representatives from all sectors i.e., police officer, civil lawyer, representative from NGO, Students (from all the years), parents (at least one from all the years) and the faculty.
- 9. The date for the next committee meet was decided.
- 10. Committee has taken steps and allotted duties to all the staff members at almost all areas in the college to avoid ragging activities.
- 11. Committee decided to wide canvassing about anti-ragging in the form of display of Flexi banners, Meetings, and Boards in college and surrounding areas where there is a chance of ragging.
- 12. Awareness programmes to be conducted in the form of meetings to the students.

SALIENT FEATURES:

- Ragging within or outside any Educational Institution is prohibited.
- Ragging means doing an act which causes or is likely to cause insult or annoy or fear
 or apprehension or threat intimidation or outrage or injury to a student.

Key Note on Anti-ragging:

- 1. A student convicted of any of the above offences, will be dismissed from the college.
- A student imprisoned for more than six months for any of the above offences will not be admitted in any other colleges.
- 3. A Student against whom there is prima-facie evidence of ragging in any form will be suspended from the college immediately.
- 4. The full text of Act 26 is placed in the College / Library
