- The cell formed reviews the guidelines/policy for Redressal of the grievance as required from time to time, which may be in accordance with those issues by college.
- Keep a record of all incidents in a book if they feel the need to register a formal complaint.
 Later, this record will be helpful

Grievance Procedure:

- Any girl student will have the right to lodge a complaint regarding concerning problem
 against various issues by writing a letter or putting the complaint to the Chairman of Girl
 Student Grievance Redressal Cell.
- The complaint will be afforded full confidentially at this stage.
- After receiving the complaint, the chairman shall convene the meeting of the cell.
- The committee then shall decide the course of action to proceed.
- The report is submitted to the Principal.
